We are looking for exceptional individuals in your community who have exemplified outstanding personal resilience, courage, determination and professional competence in the face of uncommon hardships (The Phoenix Award).

or

who have exhibited the pursuit of knowledge and skills in their field that have been exemplary. They have purposefully utilized their knowledge and skills beyond their professional mandate to serve their community and made a difference in the lives of others (The Soaring Eagle Award).

Nominees must be certified by the ICBOC.

Nomination Review Process

All nomination forms must be received at the main office of ICBOC in Vancouver British Columbia by November 15 of each year.

The Award Review Panel consists of the Executive Director, the Registrar and Director of Standards, and the Board President, or her/his designate chosen from the rest of the board members.

The Executive Director and Registrar and Director of Standards review all nominations and make further enquiries as they deem necessary.

The direct supervisor of each candidate may be contacted after their letter of recommendation has been reviewed. The staff will then provide a short list of 3 candidates for each award. This short list will then be sent to each board member for review. Board members may choose to share their comments with the Award Review Panel, and may decide to recommend a particular individual, which they will send via email to the admin office of ICBOC.

The Award Review Panel will examine the nomination forms and reference letters of all those candidates short-listed, and also review any comments offered by other board members. A vote will be taken, and a majority (2 of 3) shall decide. Announcements of the awards will be made in the latter part of January, by a press release and inclusion in our winter newsletter.

The Phoenix Award

This award is presented to an individual who exemplifies outstanding personal resilience, courage, determination and professional competence in the face of uncommon hardships. The challenges they have overcome can be professional and/or personal in nature.

The Soaring Eagle Award

This award is presented to an individual whose pursuit of knowledge and skills in her/his field has been exemplary and who has purposefully utilized their knowledge and skills beyond their professional mandate, to serve their community and make a difference in the lives of others.

Eligibility:

The person nominated must:

- ✓ Be professionally certified by the Indigenous Certification Board of Canada.
- ✓ Be employed in an agency, program, or community that predominantly serves First Nations, Inuit, and/or Métis people.
- ✓ Be employed, or have been employed and providing the care for which they are being nominated, for a period of not less than three (3) years.
